



Proposed Administrative office space reduction



Functional Areas (FTE ~45):

Administrative office proposed terms

1. Contraction of Space

- Careersource will give back approximately 5,000+/- square feet (sf) within 60 days after the lease amendment is fully executed.

2. Rate

- Careersource will pay rent on all current space through the end of 2025, with the contraction space taking effect on January 1, 2026.
- The lease term will be extended for an additional 62 months from the current expiration date of July 31, 2026, resulting in a new expiration date of September 30, 2031.
- The existing rental rent schedule to remain with three percent (3%) annual escalations through September 30, 2031.

3. Operating Expenses

The landlord shall provide a 2026 Base Year for Operating Expenses.

4. Parking

• The same parking ratio will be maintained at the existing rate.

5. Tenant Improvement Allowance

- A tenant improvement allowance of \$5 per sf will be provided for refreshing paint and carpet within the remaining leased space.
- Landlord shall be responsible for all demising costs related to the space.

6. Free Rent

The landlord will provide two (2) months of free rent for months January and February 2026.

7. Market Data

Broker provided market data for 14 spaces in downtown Orlando between 4,000 to 6,000 Sq.Ft. Rental Rates ranged between \$29.00 to \$38.00 per Sq. Ft.


The 5,000+/- sf to be returned will be located on the east side of the building, providing the landlord with the most desirable/leasable portion of the space to expedite re-leasing efforts. Please find the referenced area separately attached.




Valencia Community Hub

- ► The total space for that area is 750 square feet


Valencia will waive the lease payment for the remainder of this current fiscal year and only collect CAM






Seminole State Community Hub

- Waiting on receipt of facility use agreement, for terms


